

# **CHAIRMAN'S REPORT** JAY SHAH

It gives me great pleasure to introduce the ICC Annual Report 2024–25 – my first as Chairman of the ICC.

"I am proud to have played a part in securing cricket's place at the Olympic Games LA28, and am determined that the sport will make the most of this incredible opportunity to connect with new fans around the globe."

It is an honour, a pleasure and a privilege to have been elected to lead this great organisation, and I would like to begin by thanking the ICC Members for the faith they placed in me when they elected me unanimously last August. I'm excited to work closely with all our Member Boards as we take our organisation and our sport forward into the future.

My sincere thanks also go to Greg Barclay for serving the ICC for two terms as Chair. I greatly look forward to building on the foundations built by him and my other predecessors in the months and years to come.

This has been a banner year for the ICC. The past 12 months have seen no fewer than four ICC tournaments: ICC Men's and Women's T20 World Cups, the ICC U19 Women's T20 World Cup 2025 and the ICC Men's Champions Trophy, which made a welcome return after eight years away. Collectively, we faced down a range of challenges and delivered four successful tournaments, thrilling our loyal fans and engaging with new audiences around the world.

Excitement is now building for the three ICC tournaments that lie ahead in the coming year – and, of course, for the new cycle of the ICC World Test Championship (WTC). Test cricket remains central to our sport, as evidenced by the record prize money I was proud to announce for the recent ICC WTC Final 2025. The fact that the three editions of the WTC have produced three different winners is testament to the continued competitiveness of cricket's most iconic format.

A key focus of my time in office so far has been the return of cricket to the Olympic Games. I am proud to have played a part in securing cricket's place at the Olympic Games LA28, and am determined that the sport will make the most of this incredible opportunity to connect with new fans around the globe.

I was delighted to welcome Kirsty Coventry, the new Chair of the International Olympic Committee (IOC), to the ICC Men's Champions Trophy semi-final earlier this year, shortly before the announcement that the Fairgrounds in Pomona will host the Olympic cricket tournaments in 2028. I will continue working closely with the IOC, the LA28 Organising Committee and other stakeholders to ensure Olympic cricket in Los Angeles is a spectacular success.

Finally, I want to express my commitment to inclusivity throughout our sport, and to ensuring every player from every background and every nation has their chance to shine.

In May, I was proud to announce a special dedicated task force and fund

to support displaced Afghan women cricketers, to be delivered with the invaluable support of the Board of Control for Cricket in India (BCCI), the England and Wales Cricket Board (ECB) and Cricket Australia (CA). This new initiative is evidence of our firm commitment to solidarity through sport – and to ensuring cricket's unique power to inspire unity, resilience and hope.

My thanks, again, to you all for your support – and my best wishes for what's shaping up to be another landmark year for the sport we all hold so dear.

Our calendar this year reflects this balance – a celebration of T20Is, ODIs, and the timeless elegance of Test cricket. Each format has a unique and vital role in our sport, provided it has the ideal mix of context, contest, competition and culture.

We also continue to invest in women's cricket. We seek to incentivise elite athletes to play at their best and 07

inspire young girls to play, opening new avenues for growth of the game.

My personal focus in the year ahead will include strengthening the core propositions of our sport and collaborating across geographic boundaries as well as domains to shape its future. And at the heart of all we do are our fans. From first-time viewers to lifelong affiliates, it is our goal to deliver unforgettable experiences, unmissable moments and unparalleled experiences that resonate across borders, cultures and generations.

I wish to express my sincere gratitude to the ICC Chairman, the Nominations Committee and the Board for placing their trust in me. Having worked closely with the ICC over more than a decade, I am excited to leverage the opportunities and take on the challenges, building on the remarkable foundations laid by those before me. With the dedication of our exceptional ICC team in Dubai and across the world, combined with the strength of our global partnerships, I am confident that we will take cricket to even greater heights.



**Sumathi Dharmawardena** is appointed new ICC ACU chair, succeeding Sir Ronnie Flanagan

**Kagiso Rabada** and South Africa's spinners give South Africa their largest margin of victory in history as they win the second Test against Bangladesh and take the series 2-0

It is announced that **Imran Khwaja** will continue as ICC's deputy chair



# **NOVEMBER 2024**

India suffer a home sweep, Lockie Ferguson gets three in three, and England's women top South Africa

India win the first Test against Australia at Perth by 295 runs, **Jasprit Bumrah** taking eight wickets

West Indies win their first Test against Bangladesh by 201 runs at North Sound, with Justin Greaves scoring an unbeaten 115

Kamran Ghulam's maiden ODI century helps Pakistan clinch their ODI series in Zimbabwe 2-1

Mandla Mashimbyi is appointed South Africa women's head coach

Marco Jansen's 11 wickets earn South Africa a 233-run victory in the first Test against Sri Lanka at Durban after the visitors were bowled out for 42 in their first innings

Charlie Dean's 3-26 and Danni Wyatt Hodge's unbeaten 53 give England a nine-wicket win in the third T20I against South Africa as they take the series 3-0

Travis Head's 140 and Pat Cummins' secondinnings 5-57 lead Australia to a 10-wicket victory over India in the floodlit second Test at Adelaide

Keshav Maharaj's 5-76 wraps up a second Test victory for South Africa over Sri Lanka at Ggeberha to take South Africa to the top of the ICC World Test Championship table

Ireland complete a 3-0 women's T20I series sweep in Bangladesh, clinching the final game in the last over (pictured right)



# **OBITUARIES**

# Sajjad Akbar died 21 May 2024

An off-spinning all-rounder, he represented Pakistan in two ODIs in 1990. Aside from his brief international career, he made a significant impact in domestic cricket, playing 182 first-class matches between 1979 and 2000, taking a match haul of 15-122 for Pakistan National Shipping Corporation against Karachi in 1988. He was also a level four coach, actively involved in coaching and nurturing young talent in domestic cricket.

### Barbara 'Pip' Vyvyan died 28 May 2024

Umpired two women's Tests and two women's ODIs between 1976 and 1990.

### **David Johnson** died 20 June 2024

Known for his pace and ability to reverse swing the ball, he was elevated to the Indian side on the back of some fine performances for Karnataka in the domestic circuit. However, a lack of control limited him to just two Tests, in which he picked up three wickets. In a decade-long first-class career, he took 125 wickets at an average of 28.63 and had a hundred to his name with the bat.

# **Ken Palmer** died 23 July 2024

A classy right-handed batter and a fastmedium bowler, his sole international appearance came in the fifth Test of England's 1964/65 tour of South Africa at Port Elizabeth. After retiring from playing, he became a first-class umpire and went onto officiate in 22 Tests and 23 ODIs between 1977 and 2001.

# **Frank Duckworth**

died 21 June 2024 He was an English statistician who, with Tony Lewis, developed the Duckworth-Lewis Method to determine results in rainaffected matches. It was first used in international cricket in 1997 and was formally adopted by the ICC as the standard for setting revised targets in truncated games in 2001.

# **Billy Ibadulla** died 12 July 2024

An all-rounder who played four Tests for Pakistan between 1964 and 1967, he became the first player from his country to score a hundred on Test debut. Striking 166 against Australia at Karachi, he shared a 249-run opening partnership with fellow debutant Abdul Kadir. He represented Warwickshire for two decades and umpired 37 first-class matches before settling in New Zealand, where he became a respected coach.









**MICC** 

### **Anshuman Gaekwad** died 31 July 2024

A courageous opening batter, he played 40 Tests and 15 ODIs for India between 1975 and 1987. He scored 1985 Test runs, with a highest score of 201 against Pakistan in 1982-83, where he patiently batted for 671 minutes – then the slowest-ever double-century in first-class cricket. After retirement, he had two separate stints as India coach between 1997 and 2000, leading them to the final of the ICC Knockout Trophy in 2000.

# **Graham Thorpe** died 4 August 2024

A tough, counterattacking left-hander, he scored a century on debut against Australia at Trent Bridge in 1993 and went on to become one of England's premier batters. He played 100 Tests between 1993 and 2005, scoring 6,744 Test runs with 16 hundreds, and was also capped 82 times in ODIs. He joined the ECB in 2010 as lead batting coach and was part of the team that oversaw England's ICC Men's Cricket World Cup 2019 success.

### **Dave Quested** died 6 August 2024

Umpired five Tests, 31 ODIs and 18 women's ODIs between 1990 and 2009, including the final of the ICC Women's Cricket World Cup 2000 at Lincoln.

### Jon Hurley died 10 August 2024

A left-arm spinner, he played seven T20Is for his adopted country Argentina between 2019 and 2021, taking 10 wickets at 14.40 apiece.

### Frank Misson died 11 September 2024

Inspired to become a fast bowler after watching Ray Lindwall, he became a stellar athlete in his youth. He played five Tests across the famous 1960/61 series against the West Indies and the 1961 Ashes tour to England, taking 16 wickets at 38.50, including a career-best 4-58 against the West Indies in Melbourne. Ironically for someone who was such a fitness fanatic, his Test career was cut short by an Achilles injury, and he retired to concentrate on a sales career.

### **Brian Hastings** died 7 October 2024

An elegant right-handed batter, he featured in New Zealand's historic first Test victory over Australia at Christchurch in 1974. In all, he played 31 Tests and averaged 30.20, scoring four centuries, and shared in a then-record 151-run 10th-wicket partnership with Richard Collinge against Pakistan at Auckland in 1973. He also represented New Zealand in its first 11 limited-overs internationals and served as an ICC Match Referee in 10 Tests and 18 ODIs.

### Pat Thomson died October 2024

An off-spinning all-rounder, she made her Test debut for Australia against New Zealand in Dunedin in 1961 and toured England for the 1963 Ashes series. Overall, in four Tests, she scored 107 runs at 26.75 and claimed two wickets at 73.50. Following her cricket career, she moved to the Northern Territory to become a police officer, rising through the ranks to lead the NT Police's women's division.

# Ian Redpath died 30 November 2024

A stoic opener known for his courage, impeccable sportsmanship and wry humour, he played 66 Tests and five ODIs in an international career that ran from 1964 to 1976. He struck eight Test centuries, with a career-best 171 against England at Perth in 1970. Having scored three centuries against the West Indies in his last four Tests, he retired to work full-time for his antique business in Geelong. He returned to play World Series Cricket for two seasons and went on to coach Victoria later in life.



# **Mohammad Nazir** died 21 November 2024

An off-spinner, he played 14 Tests over a 14-year international career, taking 7-99 on debut against New Zealand at Karachi in 1969. In all, he took 34 Test wickets and added three in his four ODI appearances. A prolific wicket-taker in domestic cricket, he ended with 829 first-class wickets at just 19.26 apiece. After retiring, he turned to umpiring and stood in five Tests and 15 ODIs between 1994 and 2000.

### Sandra Brown died 22 November 2024

An all-rounder who bowled off-spin, she played all three Tests against Australia in 1963, helping England regain the Ashes with a 1-0 series win. She struck an unbeaten 57 in the drawn first Test at Edgbaston, but that was the extent of her international career.

### Arshad Pervez died 30 December 2024

A prolific batter in domestic cricket, scoring nearly 15,000 first-class runs, he represented Pakistan in two limited overs internationals against England in 1978.

### **Buster Farrer** died 31 January 2025

One of South Africa's most talented all-round sportsmen, he played six Tests between 1962 and 1964 – all against New Zealand – scoring 221 runs at an average of 27.62. An accomplished tennis player, he reached the second round at Wimbledon in 1956 and gained Border colours for golf, squash and badminton. Capped three times by the South African hockey team, he also represented his country in senior bowls and completed a Comrades Mathon in 1979.

### **Bill Sommer** died 9 February 2025

Umpired seven women's ODI matches in New Zealand between 1992 and 1999, and later served as president and chairman of the New Zealand Umpires and Scorers Association.

# **Ann McKenna**

died 24 January 2025 A talented sportswoman, she played seven Tests and 14 ODIs for New Zealand between 1969 and 1987, with a highest score of 97 not out in the 1985 Test against India at Cuttack. She went on to coach New Zealand at the 1993 and 1997 ICC Women's Cricket World Cups (pictured above, front row left, with the 1993 team), finishing as runners-up on both occasions, and won international hockey caps in 1967 and 1971.

# **Janice Parker**

died 9 February 2025 A right-handed batter who bowled medium-pace, she enjoyed a decade-long career for Victoria and represented Australia in five Tests – two on the 1963 tour of England and three in the subsequent 1968/69 home Ashes series. She scored 172 runs at an average of 24.57, with two half-centuries, and added three wickets at just 11.33 apiece.



# **Keith Slater** died 24 February 2025

A versatile all-rounder, he played one Test for Australia against England at Sydney in 1959, dismissing Peter May and Ted Dexter. The first Western Australian to play in the Ashes, he founded the Lilac Hill Festival Match, pitting a Cricket Australia Chairman's XI against an international touring team. He was also an accomplished Australian rules football player for Swan Districts, who he helped complete a hat-trick of titles from 1961 to 1963.



### **Ronald Draper** died 25 February 2025

A top-order batsman and occasional wicketkeeper and the oldest Test cricketer at the time of his death, he made a century on his first-class debut for Eastern Province in 1945. Making his Test debut with South Africa 3-0 down in their 1949/50 series against Australia, he made 15, and added seven and three in the final Test. That was the extent of his Test career, but he later became the first to score two centuries in a Currie Cup match, for Griqualand West against Border at Kimberley in 1952.

### **Godfrey Lawrence** died 12 March 2025

A fast bowler from Rhodesia, he played all five of his Tests for South Africa in the 1961/62 series against New Zealand, which ended 2-2. He was the leading wicket-taker for either side with 28 at 18.28 apiece, highlighted by 8-53 in New Zealand's first innings of the second Test at Johannesburg. He took wickets with his last two deliveries in Test cricket and remained the spearhead of the Rhodesian attack for a decade.

### Peter Lever died 27 March 2025

A tireless and aggressive right-arm fast bowler, he played an important part in England's triumphant 1970/71 Ashes victory in Australia, where his 13 wickets proved the ideal support to John Snow. He took 41 wickets in his 17 Tests and struck two half-centuries with the bat, adding 11 wickets in 10 ODIs. He enjoyed a 17-year career with Lancashire and went on to coach them between 1983 and 1986, before serving as England's bowling coach a decade later.

### **Faroog Hamid** died 3 April 2025

A tall, right-arm opening bowler, he toured Australia and New Zealand aged 19 on Pakistan's 1964/65 tour, scoring zero and three and taking 1-107 in his sole Test appearance at Melbourne. The son of Abdul Hamid, who competed at the 1928 Amsterdam Olympics, he was himself a national champion in the javelin and in the decathlon.




# Abid Ali died 12 March 2025

An all-rounder who bowled medium-pace and fielded brilliantly, he played 29 Tests for India between 1967 and 1974, scoring 1,018 runs and taking 47 wickets, and represented his country at the ICC Cricket World Cup 1975. On his Test debut he took 6-55 against Australia at Adelaide, and famously scored the winning runs as India beat England at The Oval in 1971. After retirement, he settled in America and played an active role in the Northern California Cricket Association.

# **David Renneberg** died 7 April 2025

A fast, accurate opening bowler, he represented Australia in eight Tests between 1966 and 1968, taking 23 wickets at 36.06. He played all five matches in the 1966/67 series in South Africa and three against India the following season, when he returned his best figures of 5-39 at Adelaide. After he retired from cricket, he was a radio commentator for the ABC for several years.



### Jeff Evans died 20 April 2025

Umpired five women's ODIs and three women's T20Is between 2002 and 2014, and enjoyed a 22-year career as a firstclass umpire.

### Hammond Furlonge died 6 May 2025


An opening batter from Trinidad, he struck an unbeaten 150 against the touring Australians in 1955 in just his third first-class match to earn a Test debut in the final Test of the series two months later. He played his remaining two Tests on the tour of New Zealand the following winter, striking 64 at Auckland. His nephew David has served as Trinidad and Tobago's coach.

### **Bob Cowper** died 11 May 2025

A talented left-hander and off-break bowler, he played 27 Tests for Australia between 1964 and 1968, scoring 2,061 runs at an average of 46.84, including five centuries. He is best remembered for his innings of 307 against England at the MCG in 1966, the first triplecentury scored in a Test in Australia. He retired at the age of 28 to become a stockbroker, but later returned to the game as an ICC Match Referee in two Tests and 12 ODIs.

### David Trist died 29 May 2025

A pace bowler who enjoyed a 14-year playing career in New Zealand, he then moved into coaching. Having enjoyed stints with Canterbury, South Africa and the Netherlands, he became New Zealand coach in 1999 and guided the team to victory in the 2000 ICC Knockout – their first piece of global silverware.



# **Keith Stackpole** died 22 April 2025

An aggressive middle-order batter who could also bowl leg-spin, he flourished after being moved to the top of the order and went on to play 43 Tests between 1966 and 1974, scoring 2,807 runs at 37.42 with seven centuries. He served as Australia's vice-captain for the 1972 Ashes series, in which he topped all runscorers with 485. After retiring he forged a career in the media, becoming a well-known and respected television and radio commentator.

# **CRICKET OPERATIONS**

A number of announcements spoke to the global growth of the women's game and confirmed the ICC's commitment to that trend, while the Emirates ICC Elite Panel of Umpires and Referees celebrated multiple member milestones.





# Strengthening women's cricket

Demonstrating its commitment to equity across the men's and women's games, at its Annual Conference in July 2024 the ICC confirmed that the ICC Women's T20 World Cup would comprise 16 teams, up from 12.

The ICC Board built on that announcement at its October meeting that year, following the conclusion of the ICC Women's T20 World Cup 2024, with the approval of a series of Associate Member women's T20 competitions. The series is designed to help boost competitiveness in preparation for the expansion of ICC women's events in the 2028-2031 cycle, as well as the 2025-2029 Women's Future Tours Programme and calendar. Notably, the latter included confirmation of Zimbabwe's debut place in the ICC Women's Championship, marking a significant step toward broader global representation in women's cricket.

At that October meeting, the ICC Chief Executives' Committee confirmed the mechanism for ODI status for the five Associate Member women's teams for the 2025–2029 cycle, while also announcing that the women's rankings annual update will move to 1 May from 1 October each year. Teams must now have played a minimum of eight matches, up from six, reflecting the significant increase in women's international cricket.

Other notable outcomes of the Annual Conference included the ICC Board confirming a review into the delivery of ICC Men's T20 World Cup 2024. Looking ahead, the ICC Chief Executives' Committee confirmed the allocation of the eight regional qualifying spots for the 2026 edition of the tournament.

# Landmark year for referees and umpires

The 2024–25 season saw the Emirates ICC Elite Panel of Match Referees celebrate the career of match referee David Boon, who announced his retirement in April 2025. Since 2011, he had officiated in nearly 400 international matches, including 87 men's Tests, 183 men's ODIs, 119 men's T20Is and seven women's T20Is. He has since joined Cricket Australia as a Board Director.

Other notable milestones included referee Richie Richardson officiating in a men's Test match for the 50th time when he took to the field for Pakistan against England in October 2024, and Andy Pycroft doing so for the 100th time when Australia took on India in December.

In May 2025, the ICC congratulated four-time ICC Umpire of the Year Richard Illingworth for officiating in 100 men's ODIs. He reached the landmark during Ireland's series against the West Indies.

# **ICC committees**

There were a number of changes to the ICC Men's Cricket Committee across the season. In July 2024, two appointments were approved, Paul Reiffel (Umpire representative) and Richie Richardson (Referee representative). In October 2024, Scott Weenink was appointed as the committee's Full Member representative and Scott Edwards was named as the Associate Member representative. And in April 2025, Sourav Ganguly was reappointed as Chair, while Hamid Hassan, Desmond Haynes, Themba Bavuma, VVS Laxman (reappointment) and Jonathan Trott were all appointed.

Also in April, Catherine Campbell was reappointed as a Full Member Representative of the ICC Women's Cricket Committee, joined by new appointees Avril Fahey (Full Member representative) and Pholetsi Moseki (Chief Executives' Committee representative).

In October 2024, Dr John Maclean replaced the retiring Dr Roger Hawkes on the Medical Advisory Committee.



# Decision Review System (DRS)

Further to making DRS available as standard across all major ICC men's and women's events, SMART Replay technology has also been introduced at the past three ICC events. The technology extends the use of core DRS tools, allowing the third umpire to have direct access to match replays and decision technologies to facilitate more dynamic and guicker review processes, as well as adding the ability to use ball tracking to check above-waist no balls.

There have been clear benefits, including a reduction in the number of umpire reviews, time-savings and reduced animosity about above-waist no ball decisions. The ICC aims to provide SMART Replay, or similar, at all ICC men's and women's senior age events in the future and is committed to further innovation and improvements in match technology.

# **CRICKET AND THE OLYMPIC GAMES**

Preparations continued this year for cricket's return to the world's biggest sporting stage with ICC Chairman Jay Shah meeting current and future IOC Presidents during 2025.

Cricket's return to the Olympic programme grew ever closer in 2024-25. Excitement continues to build around the world for what ICC Chairman Jay Shah describes as "a watershed moment for our sport and a real opportunity

for transformative growth for 2028 and beyond".

Shah played a crucial part in the successful campaign for cricket to be included at the Olympic Games LA28,

its first appearance at the Games since 1900. Following his assumption of his new role as ICC Chairman in December 2024, Shah has been working hard to ensure a successful Olympic return for cricket in 2028 – and has also been

looking to cement cricket's place on future Olympic programmes, starting with the Brisbane Games of 2032.

# Connecting with President Bach

In January 2025, Shah travelled to the Olympic Capital of Lausanne, where he met with Thomas Bach, President of the International Olympic Committee (IOC), and other IOC officials to discuss cricket's place on the Olympic programme. Shah and ICC CEO Geoff Allardice also took part in a seminar for the international federations of sports on the programme of the Olympic Games LA28.

"It was a productive meeting and an important milestone on the road to LA28," said Shah. "We discussed a range of critical issues and continued to build relationships with our friends across the Olympic Movement. We look forward to the next three and half years working in collaboration with the IOC and LA28."

# In with the new

In March 2025, Shah welcomed IOC Member Kirsty Coventry to the ICC Champions Trophy semi-final between

India and Australia in Dubai – just two weeks before Coventry was elected to succeed Bach as IOC President following the conclusion of his term of office in June 2025.

Coventry, a two-time Olympic swimming champion, hails from the cricketing hotbed of Zimbabwe, and served as her nation's Minister of Sport before her election as the first female President in the IOC's history.

"I look forward to working with you and your team on cricket's inclusion in the LA28 (Olympic) Games – and beyond," said Shah, offering the newly elected President his congratulations.

# LA28 venue and team numbers confirmed

April 2025 saw two major moments for cricket on the road to the Olympic Games LA28. First came confirmation from the IOC Executive Board that the men's and women's T20 tournaments at the Games will each feature six teams, with all teams fielding 15-player squads – as is the case at ICC men's and women's World Cups. Details of the qualification pathway for the Games will be confirmed in the coming months.

> Soon afterwards, the Olympic Games LA28 Organising Committee announced that the Olympic cricket tournament would take place at the Fairgrounds in Pomona, a Southern California landmark that has hosted the LA County Fair for more than a century.

# **Beyond Los Angeles**

Los Angeles wasn't the only item on Shah's Olympic agenda for 2025. In December, he travelled to Australia to meet with the Olympic Games Brisbane 2032 Organising Committee, heralding what Shah termed a "very exciting time ahead for cricket's involvement in the Olympic Movement". Hopes are high that, in the cricketing powerhouse of Australia, Brisbane 2032 will retain cricket on the Olympic programme following its return in Los Angeles.

Since assuming his role, Shah has also been keen to connect with key figures from other sports on the Olympic programme – including a meeting in May 2025 with UEFA President Aleksander Čeferin in Munich ahead of the UEFA Champions League Final 2025. As Shah said, "it's always valuable to spend time with other sporting leaders as the ICC expands our sport's global reach".







# INDIA RETURN TO THE TOP

India came out winners of an epic tussle in Barbados, bringing to an end a long wait for a world title and a tournament full of surprises.

India became the first team to win the ICC Men's T20 World Cup without losing a game, edging out South Africa in a tense final to claim their second crown. Despite being a dominant force in Test cricket in recent years, the victory was India's first World Cup title since 2011, and their first T20 title since 2007.

India set South Africa 176 to win – the highest total ever set in an ICC Men's T20 World Cup final – thanks in large part to player of the match Virat Kohli's 59-ball 76. The Proteas got off to a shaky start in their chase but settled, before Henrich Klaasen wrenched them into a strong position with a rapid-fire 52 that included five sixes – leaving South Africa needing 26 from the final four overs.

# Afghanistan shocked Australia en route to the semi-finals

Up stepped India's bowlers, led by player of the tournament Jasprit Bumrah, who proceeded to stifle South Africa's final overs and take India to victory at the Kensington Oval.

For first-time finalists South Africa, to come so close to a maiden world title was tough to take, but their run to the final is a sure sign of the Proteas' progress. "It's one step closer," said their captain, Aiden Markram. "Hopefully moving forward we can get that first win and it can be a snowball effect of quite a few to come."

# Increasing competitiveness

The closeness of the battle in Barbados – and the competitiveness of the tournament as a whole – belied the relative ease with which the finalists navigated their semi-finals. In Guyana, India set England a daunting 172 to win, ultimately claiming a 68-run victory and avenging their ICC Men's T20 World Cup 2022 semi-final defeat. In Trinidad and Tobago, South Africa faced surprise package Afghanistan, who had dispatched New Zealand, Bangladesh and Australia during a hugely impressive run to the final four, their debut at that stage of the tournament. The semi-final proved a step too far, with the Proteas cruising to a ninewicket, but Afghanistan's presence was representative of the competitiveness reflected across the tournament – the first edition to feature 20 teams.

In their first World Cup, the USA defied expectations, defeating heavyweights Pakistan to gualify from Group A.

Elsewhere, Nepal were one run away from a huge upset against South Africa, Scotland narrowly missed out on the Super Eight stage to England in Group B, and New Zealand also failed to progress from the groups after defeats to Afghanistan and the West Indies. Even eventual winners India only narrowly edged past Pakistan by six runs, while Uganda claimed their first-ever ICC Men's T20 World Cup victory by defeating Papua New Guinea.



The decision to hold matches in the USA proved a success, and augurs well ahead of cricket's return to the Olympic Games in Los Angeles.

Overall, nearly 200,000 fans attended matches during the USA leg of the tournament. India's clash with archrivals Pakistan at the Nassau County International Stadium in New York drew 34,028 fans, a record for international cricket in the USA, with another 31,722 watching the home side play the eventual champions.

Beyond the stadiums, tens of thousands attended the fan parks across the country, while ICC digital platforms witnessed record levels of engagement from the region. Across the USA leg of the tournament, 2.7m USA-based users visited the ICC website or app, a huge rise on the previous edition, with 52% of those being new fans.

# **KERR DOES IT ALL**

New Zealand won their maiden ICC Women's T20 World Cup in Dubai, beating South Africa to end a fabulous showcase for the women's game.

All-rounder Amelia Kerr led New Zealand to a historic victory in the 2024 edition of the ICC Women's T20 World Cup, the White Ferns' first World Cup triumph since winning the 50-over ICC Women's Cricket World Cup in 2000.

The White Ferns had to scrap to make the final – qualifying from the group stage only after an epic collapse from Pakistan, then barely edging out the West Indies by eight runs in their semifinal. But Sophie Devine's side rose to the occasion in Dubai, running out comfortable winners against a South African side that just ran out of steam.

South Africa won the toss and chose to field, and the New Zealand innings was in the balance at 85 for three after 13 overs. But a rapid 43 from Kerr helped them plunder 73 runs from the last seven overs and post what looked like a competitive total of 158 for five.

So it proved. South Africa's openers racked up 50 in just the seventh over, but Tazmin Brits' dismissal heralded a match-changing turnaround: five wickets for just 26 runs in 6.3 overs. The jubilant New Zealanders ran out victors by 32 runs, and Kerr ended with 3-24 to take the twin crowns of Player of the Match and Player of the Tournament.

# The road to the final

The group stage threw up its share of drama, and more than a few shocks.

The only team to go undefeated during the group stage were six-time winners and defending champions Australia. New Zealand's 58-run hammering of India in their first match left the White Ferns in pole position to progress from Group A with the Aussies – and they sealed the deal with victory over Pakistan, who lost their last six wickets for four runs in 11 balls. India ended a disappointing third, ahead of Pakistan and Bangladesh.

Group B was even tighter, as a trio of sides ended with identical 3–1 records. The West Indies' brilliant victory over England meant they topped the group - and they were joined in the semifinals by South Africa, who edged out Heather Knight's side on net run rate. Bangladesh and tournament debutants Scotland completed the group.

The semi-finals were no less dramatic – or surprising. South Africa stunned Australia in the first, restricting the Aussies to just 134 for five before reaching the target with eight wickets in hand. The next day, West Indies fell

just short of New Zealand's 128 for nine, setting the stage for the White Ferns' historic triumph.


# A landmark for cricket

The ICC Women's T20 World Cup 2024 was a landmark tournament for another reason – it was the first ICC event where women received the same prize money as their male counterparts. The overall prize pot for the tournament, which was moved from Bangladesh to the UAE owing to security concerns, was USD 7,958,080, a massive increase of 225 per cent from the previous edition of the tournament.

# INDIA TAKE THE CROWN

Rohit Sharma led India to victory at the first ICC Champions Trophy in eight years, capping a phenomenal year for India's men at ICC senior events. The return of the ICC Champions Trophy after an eight-year pause saw the return of familiar winners – and no one could say they didn't deserve it.

After eight teams faced off across 19 days in Pakistan and the UAE, it was India who came out on top of the world. Rohit Sharma's men became the first team to win three ICC Champions Trophy titles – and just as they had at the ICC Men's T20 World Cup 2024, they did so without losing a match.

New Zealand did their level best to halt the Indian juggernaut in the final.

The Kiwis posted 251 for seven in their 50 overs after winning the toss, led by a quickfire half-century from Michael Bracewell. But a fast start from openers Rohit Sharma and Shubman Gill put India in pole position – and despite losing wickets regularly to the canny Kiwi attack, they made it home by four wickets with an over to spare.

# The road to the final

The two finalists both emerged from Group A, with each team's opening match proving crucial in this compact tournament format. New Zealand stunned hosts Pakistan in the opening match, with tons from Will Young and Tom Latham lifting them to a daunting total of 320 for five and a 60-run hammering. India, meanwhile, strolled past Bangladesh with ease, led by an unbeaten ton from Gill. When India beat Pakistan and New Zealand took care of Bangladesh in the following Group A matches, both sides were confirmed as semi-finalists.

The only side in Group B to complete all their matches was England, who lost the lot in what proved to be Jos Buttler's swansong as captain. South Africa's closing victory against England

ensured they topped the group ahead of Australia (one win, two no-results), with Afghanistan completing the table in third position.

But it was the Group A teams who made it to the final. A solid performance from the middle order saw India past Australia in the first semi-final with nearly two overs in hand, before tons


from New Zealand's Kane Williamson and Player-of-the-Tournament Rachin Ravindra set South Africa an insurmountable 363 in the second.

# Looking ahead


The tournament was hosted by the Pakistan Cricket Board, with India

And there's more: the first ICC Women's Champions Trophy is set to take place in 2027, with six teams set to battle in Sri Lanka for what's set to be a popular showcase for the women's game.

# SOUTH AFRICA, AUSTRALIA QUALIFY FOR FINAL

The third cycle of the ICC World Test Championship saw South Africa spring a surprise and lead the way to the showpiece Lord's final.



After 21 months, 27 series and 69 Test matches, two teams rose to the top of the ICC World Test Championship 2023–2025 table – and they perhaps weren't the two that many fans had expected.

# Proteas lead the way

The eventual table-toppers were also the first team to book their place at Lord's for the showpiece final – none other than South Africa. The Proteas had just missed out in the previous cycle, with India pipping them for second place, but Temba Bavuma's men made no mistake this time around.

The clinching moment came at Centurion in December 2024, when a ninth-wicket stand of 51 from Marco Jansen and Kagiso Rabada led South Africa to a thrilling two-wicket win over Pakistan and secured their spot in the final.

"To play the World Test Championship Final at Lord's is a dream come true for any cricketer," said Bavuma. "It's a huge occasion, and we can't wait to take it all in."



# Aussies set to defend title

Their final opponents were confirmed a week later, when defending champions Australia completed a 3–1 win over India to seal their spot at Lord's.

"To hold the [Border-Gavaskar] Trophy is an amazing feeling, and the extra layer is now securing a spot in the World Test Championship Final, which was always a huge goal for us in this cycle," said captain Pat Cummins.

"We talk about the World Test Championship a lot. I think it's a great tournament in that you've got to play well consistently and across all different conditions against different teams. We can't wait to get over there."

# The best of the rest

India were many pundits' favourites for the title, but Rohit Sharma's men could only finish a distant third. The turning point in their campaign was an extraordinary 3–0 home series defeat to New Zealand in October– November 2024, which began with the Kiwis skittling the Indians for just 46 in Bengaluru. New Zealand's triumph, the most extraordinary result in the cycle, helped them to fourth place in the table.




# ICC WORLD TEST CHAMPIONSHIP

Below them were England, who would have finished higher than fifth were it not for 22 points deducted for slow over-rates. Sri Lanka's five Test wins during the cycle put them into sixth place, ahead of Bangladesh, the West Indies and Pakistan.

For the second successive cycle, England's Joe Root topped the run-scoring table, making just shy of 2,000 runs at an average of 55. The top five wicket-takers, meanwhile, were all from Australia and India – led by Indian paceman Jasprit Bumrah, whose 77 scalps came at a preposterous strike rate of a wicket every five overs.

# **ICC Women's Cricket** World Cup 2025 Qualifier

April 2025 saw six teams travel to Pakistan for the ICC Women's Cricket World Cup 2025 Qualifier, battling for the right to complete the eight-team line-up for the ICC Women's Cricket World Cup later this year.

Pakistan led the pack from start to finish: beating Ireland by 38 runs in the opening match, sealing qualification with an 87-run defeat of Thailand, and then completing a perfect tournament - five matches, five wins - with a seven-wicket win over Bangladesh.

The second qualification slot

losses in their final two matches against the West Indies and Pakistan opened the door for Hayley Matthews' side, but only if they could win their final match against Thailand by a sizeable margin.

When Thailand were bowled out for 166, the West Indies knew they would qualify if they chased down the target in 10.1 overs – but despite a 29-ball 70 from Matthews, they fell agonisingly short.

Bangladesh ended the tournament with a net run rate of 0.639, just 0.013 higher than the Windies' 0.626 but that was enough to seal their place at the ICC Women's Cricket World Cup 2025.

# ICC U19 Women's **T20 World Cup 2025 Regional Qualifiers**

Late 2024 saw the completion of regional gualification for the ICC U19 Women's T20 World Cup 2025

Scotland thumped the Netherlands 3–0 in the Europe Qualifier, opening with a tone-setting 10-wicket win.

Nigeria booked their first place through the Africa Qualifier, beating Zimbabwe by dint of finishing higher in the group stage after the final was washed out.

Nepal edged past the UAE on net run rate at the Asia Qualifier, sealing the deal with an eight-wicket win in Dubai.



# **INDIA RETAIN THE TITLE**

The second ICC U19 Women's T20 World Cup had the same result as the first – India swept all before them to take the title with room to spare.

India were hot favourites going into the ICC U19 Women's T20 World Cup 2025 in Malaysia – and, it turned out, for good reason. India dominated every team they played, winning all seven of their matches by wide margins: eight wickets, nine wickets (on three occasions), 10 wickets, 60 runs and 150 runs.

Their dominance extended to the knockout stages. Having dispatched England by nine wickets with five overs to spare in the first semi-final, India came up against a South African team fresh from an impressive five-wicket defeat of Australia. But the Proteas were bowled out for just 82 from the last ball of their 20th over, leaving Player of the Tournament Gongadi Trisha to guide India home with 52 balls in hand.

# From 16 to one

Rewind two weeks, and hopes were high among the 16 qualified teams, including no fewer than six Associate Members. Malaysia, Nepal, Pakistan and Samoa all went winless in the group stage and were the first teams to be eliminated – but ICC World Cup debutants Nigeria progressed thanks to a stunning two-run upset of New Zealand, certainly the shock of the group stage.

Nigeria continued their fine form in the Super Sixes with a six-run win over Ireland. But rain brought their fairytale tournament to a close, with a washout against England ensuring they finished a creditable third in Super Six Group 2, ahead of the USA, New Zealand and Ireland.

Over in Group 1, Sri Lanka's 12-run victory over Australia meant they pipped Bangladesh to third place, with Scotland and West Indies completing the group.

# COMMERCIAL

New broadcast agreements and marketing initiatives extended cricket's reach, taking the sport to audiences around the globe and delivering record-breaking figures for flagship ICC tournaments.



The ICC Men's T20 World Cup 2024 marked the official start of the ICC's new 2024–31 broadcast cycle, which introduced a significant change of approach: for the first time, the ICC Board established direct relationships with broadcasters, moving away from the traditional global gateway model.

The ICC Media Rights team successfully secured 47 media rights revenue

contracts covering the 2024–27 period. This strategic shift has already delivered significant financial returns. Remarkably, media rights revenue for the new cycle is more than double the total generated during the previous eight-year period (2016–23), which will substantially benefit ICC Members.

To better provide for under-served markets, the ICC decided to self-exploit rights in selected regions via ICC.tv, its digital platform, ensuring broader access and visibility for fans in emerging territories.

Alongside the new partnerships, the ICC extended its agreement with IMG Arena to cover all senior men's and women's Pathway Events through to 2027. These rights have been structured to ensure global coverage via ICC.tv, with India-specific streams managed by the relevant licensee.



# Most-watched events set new benchmarks


The ICC's partnership and broadcast innovations have already borne fruit, with the **ICC Men's T20 World Cup 2024** the most watched edition in the event's history.

Star India played a pivotal role, delivering the event across multiple linear channels and Disney+ Hotstar in India, and offering coverage in nine languages to cater for the country's diverse audience. The collaboration exemplifies the ICC's commitment to forging impactful partnerships that expand the reach and resonance of cricket globally.

The **ICC Champions Trophy 2025** also delivered outstanding results, and significant increases in viewership compared with the 2017 edition. The event demonstrated its unique ability to captivate audiences across the globe with a condensed schedule involving the world's best teams.

The Indian market again accounted for the lion's share. JioStar, the country's





biggest broadcaster, deployed 29 unique feeds in nine languages, helping India account for 3.15 billion viewing hours alone. The country's top three most-viewed overseas ICC matches ever took place at the ICC Champions Trophy 2025: the final, India's groupstage match against Pakistan and their semi-final against Australia.

A dedicated campaign, 'All on the Line', helped build the excitement for what was Pakistan's first ICC event in nearly 30 years. Content featuring the tournament's star-studded list of ambassadors drove more than 70 million video views on social and earned media, while the PR campaign helped achieve a reach of 2.8 billion across TV, print and digital mediums. A global trophy tour spanning nine countries and more than 60 live activations, plus the release of a tournament song – 'Jeeto Baazi Khel Ke', sung by global star Atif Aslam – both added to the anticipation ahead of an official launch event at Lahore Fort, which was lit up in the colours of the tournament.

Continuing the festival atmosphere, Coca-Cola added some extra fizz to the final, putting on a spectacle during halftime with a performance of 'Holi Aayi Re' – a music track from Coke Studio Bharat inspired by Holi celebrations, blending the soul of Indian folk with a contemporary sound. "It turned the stadium into a celebration," said Anurag Dahiya, the ICC's chief commercial officer. "Fans were at the heart of it all – and their incredible response made the moment even bigger."

The **ICC Women's T20 World Cup 2024** also set new standards. A spectacular laser show illuminated the iconic



Burj Khalifa to announce the tournament's arrival in the UAE, for which tickets were available for as little as five dirhams and free of charge for under-18s. The initiative paid off, with the 91,030 fans who attended games represented a 30% increase on the number from the previous edition, while India versus Pakistan set an ICC Women's T20 World Cup record for highest group-stage match attendance (15,935). Overall, the tournament's reach exceeded 2.1 billion people.

The ten participating team captains gathered for a special captains' day ahead of the first match to further build anticipation, with a similar initiative again proving successful ahead of the **ICC U19 Women's T20 World Cup 2025**, bringing the 16 team captains together in the shadow of Kuala Lumpur's famous Petronas Towers.

# DEVELOPMENT AND INITIATIVES

The ICC continues to boost participation and improve the playing experience, particularly at grassroots level and among women and girls, through a mix of initiatives and partnerships.

### Growing the youth game

Driving participation through youth cricket remains a top priority for ICC Members. The 2024 ICC Development Survey reinforced this, revealing that 75% of ICC Members see youth or modified formats of cricket as a primary focus, aligning with the ICC's strategic emphasis on grassroots development.

To date, the ICC's criiio Facilitator Training Programme has been completed by 4,675 people, including 1,311 in the past 12 months alone. Some 92% of ICC Members now have a certified criiio facilitator, who between them have delivered criiio to 158,085 participants globally – 49% of them female.

The programme expanded significantly across 2024–25. Notably, criiio was introduced to schools in the USA as part of the ICC Men's T20 World Cup 2024 legacy project (see below). Argentina Cricket also launched its inaugural criiio programme, 'Women's Power Play', a community-driven initiative to foster female participation; Brazil's 'Cricket Like a Girl' programme engaged more than 42,000 girls; Suriname's multicentre approach reached thousands; while school-based criiio has been launched in Cyprus and Tanazia with the support of government and sport and educational bodies.

In response to Member feedback, a modified 6v6 format has been developed and was successfully piloted in Japan in April 2025.

Earlier in the year, the ICC built on its female-specific soft-ball participation programme, piloted in 2024, through which 10 participating Members were given communications resources and customised kit to run soft-ball cricket. Some 90 festivals were delivered between July 2024 and March 2025, engaging more than 3,000 women and girls, with a further 100 planned before March 2026. In its second phase, the programme will double to 20 countries.





#### Boosting women's cricket

The ICC announced its first dedicated women-only partnership in March 2025, teaming up with Unilever. The announcement took place in Dubai on International Women's Day, where 100 girls participated in a criiio cricket festival.

This first-of-its-kind partnership marks a significant milestone for cricket, with two pioneering forces teaming up to accelerate the development of women's cricket on a global scale – including activations at all major women's events and the expansion of criiio cricket festivals globally.

#### Going beyond the game

DP World distributed the eighth of its award-winning Beyond Boundaries shipping containers at the ICC Men's T20 World Cup 2024 in the USA. Each container comprises 250 cricket kits, and doubles up as a cricket <u>pavilion</u>.



#### ICC tournaments leaving lasting legacies

The ICC Men's T20 World Cup 2024 was historic for multiple reasons, including for being the first time the ICC deployed a formal tournament legacy programme. The programme aims to leave an enduring positive influence on cricket communities in host countries and the surrounding regions, with the USA and the Americas representing a huge opportunity for cricket's growth especially with cricket's Olympic return at LA28.

Taster criiio festivals were held in Florida, Dallas and New York, with criiio activities introduced in schools. Overall, more than 2,500 students were involved, while more than 1,200 teachers have been trained across Dallas and New York. Level 1 umpire and umpire courses were also delivered, while high-performance seminars organised during the tournament shared best practice with ICC Members from the Americas region.

In the UAE, the number of Get Into Cricket hubs, which help young girls get involved in cricket, has been expanded as part of the ICC Women's T20 World Cup 2024 legacy programme, alongside a series of 10 soft-ball cricket festivals. Other initiatives include funds to develop an annual girls' league, the promotion of women-only umpire and coach courses, the creation of a

female officiating panel, and leadership workshops for female administrators.

Expanding cricket opportunities for women and girls is the key feature of the ICC U19 Women's T20 World Cup 2025 legacy programme, too, a fiveyear plan delivered in partnership with the Malaysian Cricket Association and Universiti Kebangsaan Malaysia.



## **Training and education**

The ICC Training and Education platform continues to play a key role in improving the quality of coaching and officiating. Since its launch in 2021, there have been more than 36,000 coaching, umpire and pitch curation course completions. Almost 13,000 hybrid and online courses were completed between 1 June 2024 and 31 May 2025 alone, reflecting not only a growing demand for training but also the popularity of cricket itself. A large proportion (nearly 82%) were online-specific courses, while courses are now offered in 14 languages – testaments to the platform's flexibility.

#### Highlights from the year include:

- the launch of the new Level 2 and Level 3 Coaching Courses, completing the pathway from foundation to high performance;
- collaboration with ICC Members to deliver training programmes for teachers to deliver cricket in schools; and
- over 90% of Members expressing satisfaction with the ICC's training and education programme according to the 2024 Development Survey.



#### Supporting athletes' mental health

The ICC Mental Health Awareness Programme was launched in 2024 in collaboration with the International Olympic Committee (IOC). The global initiative aims to increase awareness of challenges faced by high-performance athletes, especially women. Alongside powerful, athletefocused content shared on ICC platforms and at ICC events, an agreement to develop mental-health guidelines and training modules for ICC Members and officials was signed with the UK Sports Institute.

The IOC also supported a Cricket Italy project using cricket as a platform for integration, empowerment and education, with mixed-gender sessions provided to under-represented adults and children. 'Cricket+' educational workshops were also held, while 50 new foundationlevel coaches have been trained. supported by bilingual coaching and training resources.

### Associate Members deliver on the international stage

It was a big year for Associate Members in Latin America: Brazil and Mexico took part in a regional gualifier for the ICC Men's T20 World Cup for the first time, Argentina defeated Canada in an ICC Women's T20 World Cup Qualifier; and the USA U19 women's team reached the Super Sixes of the ICC U19 Women's Cricket World Cup 2025. Scotland recorded their first win in the same competition, while their senior women's first appearance in ICC Women's Cricket World Cup Qualifiers featured wins against the West Indies and Thailand.

In a strong year for African teams, Uganda registered its first win at an ICC Men's T20 World Cup, beating Papua New Guinea. The Tanzanian U19 men's team made history by gualifying for the

#### **Building on work** with UNICEF

The first benefits of the ICC and UNICEF's global partnership agreement signed in May 2024 came to fruition across 2024–25, with ICC flagship tournaments providing a valuable platform to support UNICEF's work.

Cricket for Good clinics – a joint ICC-UNICEF initiative that uses cricket to promote health, education and well-being – were held across ICC Champions Trophy 2025 host cities in Pakistan, giving children the opportunity to attend educational sessions and meet and play cricket with their favourite stars from participating teams.



Clinics were also held at ICC Men's T20 World Cup 2024 host cities in the West Indies, a tournament that also provided an opportunity to support UNICEF's fundraising – cricket



ICC U19 Men's Cricket World Cup 2026, going unbeaten at the Africa Qualifiers. Malawi's U19 women's team won the ICC U19 Women's T20 World Cup Africa Division 2 Qualifiers, going unbeaten, while Nigeria made a remarkable debut at the main tournament, beating New Zealand and Ireland on their way to finishing sixth. Nigeria played in the same group as Samoa, who qualified off the back of a stunning run in the East Asia-Pacific Qualifier – the first time a Samoa team had ever reached a cricket World Cup, across any format or age level.

In May 2025, UAE secured a maiden international triumph over Bangladesh during a three-match T20I series, while Nepal Women celebrated reaching the global ICC Women's T20 World Cup Qualifier for the first time, having beating UAE in their regional qualifier.

legends Yuvraj Singh and Shahid Afridi participated in a special event in New York, for example, and Edible Arrangements CEO Tariq Farid committed USD 500,000 to UNICEF to help children in Pakistan.

Cynthia McCaffrey, UNICEF India Representative, spoke at the ICC Annual Conference, highlighting the importance of sport for empowering girls. National-level partnerships between UNICEF regional offices and ICC Members to harness the power of cricket to enable, empower and equip girls with key life skills are in discussion.



# **100% CRICKET**

The ICC's campaign to change perceptions, create heroes and build excitement about women's cricket continued to promote gender equity across 2024–25, further increasing the visibility of women's cricket and offering development opportunities for women in cricket.

#### Expanding opportunities for aspiring women in cricket

The ICC's 100% Cricket Future Leaders Programme (FLP), a key vehicle for the ICC's long-term commitment to accelerating the growth of women's cricket, was enhanced in 2024. The changes aim to provide more world-class development opportunities than ever to aspiring female leaders in the sport through two distinct workstreams: administrators and coaches. The FLP for administrators has been extended to 10 months and features more interactive elements. The fourth edition got under way in October 2024 in Dubai with the first of two three-day workshops, which was delivered by former Australia captain Belinda Clark.

The 15 selected participants, including five from Associate Members, have been paired with senior cricket figures who offer online mentorship and career development support. All participants are working on projects focused on growth, commercialisation and marketing that will be presented to Members.

#### FLP for coaching

To help address the low percentage of women in leadership positions within cricket, an FLP for coaches was delivered for the first time in 2024. More than 30 coaches from 22 Member countries, the majority Associate Members, benefited from the programme, which ran between May and November 2024.





The aspiring coaches were exposed to high-stakes tournament environments at ICC regional pathway events on the road to the ICC U19 Women's T20 World Cup 2025, taking part in a blend of practical coaching and mentorship sessions. In 2025, there will also be a focus on providing these coaches the opportunity to complete an ICC Level 2 certification.

Emirates, Premier Airline Partner of the ICC, continued its support for the FLP and provided exclusive fares for participants.

## Promoting women's health education

Women's health education continued to be a focus at ICC

women's events across 2024–25. Health education sessions were delivered to all ICC Women's T20 World Cup 2024 teams, with a focus on pre-conception education for players, and to teams at the ICC U19 Women's T20 World Cup 2025, with a focus on menstrual health.

The ICC also organised a second women's health webinar for all Members, aligning with Menstrual Hygiene Day, on 28 May 2025. Titled 'Breaking barriers around periods in cricket', the webinar was attended by more than 200 people.

To increase its reach, the webinar is available on the ICC's 100% Cricket website, while an animated video on menstrual health has also been made available to Members.

## Protecting women cricketers online

In October 2024, the ICC provided a service that offers protection to the social media channels of players and teams participating in ICC women's events, hiding abuse and negative comments across multiple languages. More than 80 players signed up for the service during the ICC Women's T20 World Cup 2024 and the ICC U19 Women's T20 World Cup 2025.





# DIGITAL

The ICC Champions Trophy 2025 led the way with record engagement figures – reward for the ICC's commitment to delivering innovative digital content to fans across the world, bringing them closer to the action than ever before.

The 2025 edition of the ICC Men's Champions Trophy represented a new benchmark in digital engagement for the competition, with 8.7 billion video views on tournament-related content across all ICC digital channels.

Giving fans a glimpse beyond the on-pitch action proved popular – with clips of India's raw victory celebrations, in their iconic white jackets, ranking among the most viewed pieces of content. In the 48 hours that followed the final, scenes such as Virat Kohli and Shreyas Iyer dancing on the field and

Rohit Sharma parading with the trophy garnered 2.1 billion views alone.

Other best-performing posts including Abrar Ahmed's incredible ball to dismiss Shubman Gill in the India–Pakistan match, and ICC Chairman Jay Shah retrieving the ball following a monster six by Hardik Pandya in the India–Australia semi-final.

The ICC's live streaming platform, ICC.tv, made sure that fans didn't miss a ball. More than 700,000 individual viewers followed the action from emerging

territories, with fans in Nepal, Germany, France, Malaysia and Italy topping the charts for viewing minutes on ICC.tv.

Adding to the ICC's efforts to enhance the digital experience for fans, ICC Recapped, an artificial-intelligencepowered initiative deployed in partnership with NEAR, offered a new level of engagement. Fans were provided a summary of their supporting activities during the tournament such as how often their predictions were accurate and which players they voted for the most.

#### **Hindi channels** launched on Instagram and Facebook

Ahead of the ICC Men's T20 World Cup in 2024, the ICC launched dedicated Hindi language social media channels on Instagram and Facebook, further helping cricket reach its diverse fanbase. Between them, the channels have attracted nearly 1.5 million followers, up from just under half a million at the start of 2025, and nearly 2.5 billion video views. Capturing powering moments with Hindi commentary and leaning into local and popular culture have proved particularly successful.

A suite of digital initiatives helped take the ICC Men's T20 World Cup 2024 to fans all over the globe, with ICC.tv at the forefront. Video content was placed at the heart of a new ICC website and app, with ICC.tv also embedded in the main ICC website and app for

More than four million fans signed up to watch live matches on ICC.tv across the year, between them viewing more than 3.2 million hours of content, while

the platform carried live coverage of the ICC Men's T20 World Cup 2024 into more than 80 non-traditional territories, offering unprecedented access to live matches, highlights and other content. The list of countries topping the viewing figures glimpsed at the potential for cricket's growth into new markets: Nepal, Malaysia, Japan, Korea, Germany and France.

The ICC Women's T20 World Cup 2024 content also saw strong engagement, attracting a total of 1.7 billion video views - up 22% from the 2023 event.







# **GOVERNANCE**

The appointment of Jay Shah as the ICC's new Chairman was the key announcement of the year.

Jay Shah assumed the position of ICC Chairman on 1 December 2024, having been elected unopposed in August following former ICC Chair Greg Barclay's announcement that he would not seek a third term.

"I am committed to working closely with the ICC team and our member nations to further globalise cricket," said Shah on his election. "We stand at a critical juncture where it is increasingly important to balance the coexistence of multiple formats, promote the adoption of advanced technologies and introduce our marquee events to new global markets. Our goal is to make cricket more inclusive and popular than ever before."

Earlier in 2024, Imran Khwaja, Mubashshir Usmani and Mahinda Vallipuram were elected as Associate Member Directors for two-year terms at the 2024 ICC Annual Conference in Colombo. Khwaja was re-elected, while Usmani and Vallipuram replaced Pankaj Khimji and Neil Speight. Usmani was also appointed as the Chair of the Associate Members.

Usmani's appointment to the Board triggered an election for his Associate Member representative position on the Chief Executives' Committee (CEC). Following an election in September, Botswanan Sumod Damodar was elected to serve the rest of the term, which concludes at the 2025 ICC Annual Conference.

#### **Term-length** changes approved

In October 2024, the ICC Board recommended an amendment to the ICC Constitution to change the termlength/limits of the ICC Chair and the Independent Director to a maximum of two terms of three years, instead of three terms of two years, with the sixyear total limit remaining. The changes were accepted by ICC Members with effect from 1 December 2024.

October also saw Khwaja reappointed as ICC Deputy Chair, with his new tenure starting on 1 December 2024. Khwaja was first elected to the ICC Board in 2008, and has served as Deputy Chair since the position was introduced in 2017.

#### Membership Criteria noncompliance notices issued

Following the 2024 ICC Annual General Meeting, USA Cricket and Cricket Chile were formally put on notice and given 12 months to rectify their non-compliance with the ICC Membership Criteria. Neither Member was considered to have in place fit-for-purpose governance and administrative structure and systems.

The ICC Americas office has been supporting Cricket Chile in remedying their non-compliance, while the ICC Board set up a Normalisation Committee to oversee and monitor USA Cricket's compliance roadmap.





# INTEGRITY

## Protecting cricket and everyone involved in the game remains a fundamental commitment of the ICC, which continues to guard against corruption and doping.

## Anti-corruption

The ICC Anti-Corruption Unit (ACU) initiated 115 investigations across a broad spectrum of incidents during 2024–25, with 93 investigations (some initiated before the 12-month period) active as of 31 May 2025.

Five cases filed in September 2023 under the Emirates Cricket Board Anti-Corruption Code in relation to the 2021 Abu Dhabi T10 were concluded between July and November 2024:

- Shadab Ahmed accepted an agreed sanction and was banned for two years, with six months suspended (July 2024).
- Ashar Zaidi accepted an agreed sanction and was banned for five years, with 12 months suspended (July 2024).
- Parag Sanghavi accepted an agreed sanction and was banned for two years, with 12 months suspended (July 2024).
- Krishan Kumar Chaudhary accepted an agreed sanction and was banned for two years, with 12 months suspended (August 2024).
- Sunny Dhillon was banned for six years following a tribunal hearing (November 2024).

• Praveen Jayawickrama accepted a ban of one year, with six months suspended (September 2024), following charges in August 2024

Two further cases concluded in 2024-25:

• Shohaly Akhter accepted an agreed sanction and was banned for five years (February 2025), after becoming the first female player to be charged under the ICC Anti-Corruption Code.

under the ICC Anti-Corruption Code.

As cricket grows globally, the ICC continues to proactively respond to new risks through evolving initiatives and a commitment to education. To help consolidate rules and provide added clarity, a new global version of the ICC Anti-Corruption Code was launched in June 2024. Other developments during 2024-25 included:

- ACU education briefings to 2,369 cricket event participants;
- regional integrity workshops;
- the launch of the Associate Member Integrity Action Plan 2025–29; and
- the strengthening of external partnerships, including with law enforcement, the United Nations Office on Drugs and Crime (UNODC), other sporting integrity bodies and the International Olympic Committee ahead of cricket's inclusion at LA28.

#### Anti-doping

Education remains a core plank of the ICC's approach to anti-doping. Alongside delivering education sessions to approximately 700 players and event staff across 2024–25, the ICC launched a dedicated awareness campaign -Integrity Is My Legacy – during the ICC U19 Women's T20 World Cup 2025, reinforcing the importance of fair play through interactive, fun-based learning. The campaign will feature at all ICC U19 World Cups going forward, with plans to expand it to other events.

The ICC collected 513 samples (70% men, 30% women) across 2024-25. Of these, 62% were no-notice, outof-competition tests, reflecting the ICC's commitment to effective and unpredictable testing.

A revised whereabouts system came into effect on 1 July 2024, enhancing testing strategy and intelligenceled approaches. Eight players were elevated into the ICC's International Registered Testing Pool, requiring them to submit whereabouts information on a quarterly basis.

There were seven anti-doping violations recorded in domestic cricket, involving players competing in the Caribbean, England, Italy, New Zealand, South Africa and Sri Lanka. Four involved substances classified under the 'substance of abuse' category, while

one involved a refusal to submit to sample collection.

#### Security

The ICC strives to make events safer for all, and this year supported the delivery of three major global sporting events, two of which were moved from their original host nations. A thorough review of safety and security protocols has supported hosts to plan for and mitigate risks. Thorough briefing and debriefing at all events and collaboration with international sports federations has enabled cricket to recognise and adopt best practices, and to continuously evolve its approach.

## Safeguarding

The ICC continues to ensure the welfare of everyone involved in ICC events guided by the ICC's comprehensive Safeguarding Regulations, freely available on the ICC website. The ICC advertises its secure safeguarding reporting line through wide-ranging communication strategies, including posters, advisory notes, tournament handbooks and staff handbooks working closely, where relevant, with local organising committees. The ICC also provides advice to ICC Member boards to support them in developing similar protections and processes.

## **Reinforcing a**

strategic approach The ICC Integrity Unit formalised its strategy in 2025, renewing its commitment to protecting cricket by fostering a culture where safety, respect and integrity are embedded at every level of the game. Central to the unit's approach are effective education, awareness-building. the provision of timely and relevant information, and close collaboration with ICC Members.



# **BEST IN CLASS**


Jasprit Bumrah and Amelia Kerr topped the bill at the ICC Awards 2024, recognised for their outstanding achievements alongside eight other winners and five ICC Teams of the Year.


Jasprit Bumrah closed a momentous 12 months by winning both the Sir Garfield Sobers Trophy for the ICC Men's Cricketer of the Year and the ICC Men's Test Cricketer of the Year award. It was just reward for a year in which he took 71 Test wickets at a staggering average of just 14.92, and picked up the Player of the Tournament award at the ICC Men's T20 World Cup 2024.

Amelia Kerr became the first New Zealander to win the Rachael Heyhoe Flint Trophy for ICC Women's Cricketer of the Year, having inspired the White Ferns to their first ICC Women's T20 World Cup title. Across 2024, Kerr hit 387 runs and took 29 wickets, feats that saw the all-rounder also named the ICC Women's T20I Cricketer of the Year.

Arshdeep Singh was crowned ICC Men's T20I Cricketer of the Year. Singh was India's leading T20 wicket-taker at an average of just 15.31 – particularly impressive given that he predominantly bowls in powerplay and death overs.

Azmatullah Omarzai of Afghanistan and Smriti Mandhana of India won the ICC Men's and Women's ODI Cricketer of the Year Awards respectively. Omarzai finished 2024 as his country's second-highest run-scorer and wickettaker, while Mandhana scored an incredible 747 runs in 13 matches. Kamindu Mendis of Sri Lanka and Annerie Dercksen of South Africa were recognised for breakthrough years with the ICC Men's and Women's Emerging Cricketer of the Year awards. A pair of captains – Namibia's Gerhard Erasmus and the United Arab Emirates' Esha Oza – were named ICC Men's and Women's Associate Cricketer of the Year.

**Richard Illingworth** won the ICC Umpire of the Year category for a third consecutive time, and the

fourth overall.



## **AUDIT COMMITTEE CHAIR'S REPORT**



It is an honour to present my second report on behalf of the Audit Committee, following the Audit Committee Meeting in April 2025.

This year saw us welcoming new ICC Chairman Jay Shah to the Audit Committee. His experience gives us a considerable advantage across all our functions, and we hope to benefit from his presence in every way possible.

We also welcomed fellow directors Mirwais Ashraf, Mike Baird, Dr Mohammed Moosajee and Mahinda Vallipuram to the Audit Committee, and Elaine Jones as an independent member. Their expertise and knowledge significantly aided the discharge of the committee's role as a collective throughout the period.

The ICC Audit Committee met on two occasions between 1 June 2024 and 31 May 2025. The Committee continued to focus on ensuring that the ICC's internal systems and controls are effective and responsive to a challenging external environment, while evolving in line with an ever-increasing need to be more efficient in all operational matters. The Committee continued to discuss a number of important issues, including corporate taxation and cyber security, which remain high-risk areas in a multi-jurisdictional and geographically widespread organisation such as the ICC.

Throughout this period, the ICC management apprised us on business operations, evolving corporate risks and their management, ethics, and code-of-conduct-related processes.

We also welcomed the newly appointed external auditor, KPMG, who presented their first report and succeeded EY, who had served the ICC for a number of years

As per the Committee's Terms of Reference, we are required to review the audited financial statements and the external auditor's report and make appropriate recommendations. At the April meeting, we reviewed and discussed the external audit report and draft statements for the period 1 January 2024 to 31 December 2024. The review included assessing the accounting principles, significant estimates, the auditor's independence and the overall presentation of the financial statements.

As part of our core role, we also evaluated the external auditor's performance and independence and the impact of any non-audit services on their objectivity.

The first meeting of every year also requires us to endorse the Statement of Internal Control (issued by the management) to the ICC Board in order to provide them with the necessary assurances regarding the adequacy and effectiveness of the internal control framework. This statement is prepared after due consideration of, the results of the audits undertaken by the internal audit department, the extent to which audit recommendations have been implemented, the integrity of the ICC's risk management process; minutes of key ICC committees, and discussions and reviews carried out alongside other relevant areas of ICC business throughout the 12-month period.

In my closing remarks, I express my gratitude to the ICC Chair, directors, Head of Internal Audit and management, who continue to show the utmost cooperation and support in enabling the Committee to achieve its objectives.

#### NOTES TO SUMMARY CONSOLIDATED FINANCIAL STATEMENTS

#### **1** ACTIVITIES

The International Cricket Council Limited (the "Company" or "ICC") is a company limited by guarantee and does not have share capital, it is incorporated in British Virgin Islands. The registered office of ICC is at Commerce House, Wickhams Cay 1, P.O. Box 3140, Road Town, Tortola, British Virgin Islands. There are currently 108 Members.

The ICC Group's principal place of business is at Street 69, Dubai Sports City, Sheikh Mohammad Bin Zayed Road, P.O. Box 500070, Dubai, United Arab Emirates. The international Cricket Council Limited ("the ICC Group") comprises the Company and its subsidiaries as indicated in Note 2 to the summary consolidated financial statements.

The International Cricket Council Limited ("ICC") is the international governing body for International Test Match, International One-Day and International Twenty20 cricket. The ICC is primarily responsible for all aspects of the day-to-day operations and the development of international cricket. This extensive remit includes management of the ICC Code of Conduct, the playing conditions and all other regulatory functions and services relevant to the international game, provision of qualified and independent Match Officials for Tests, One Day and Twenty20 Internationals and initiating and implementing key policy decisions for the benefit of the game.

#### FINANCIAL MODEL: 2015-2023 CYCLE

In June 2017, the Members approved a financial model for the period 2015-2023 whereby ICC, amongst others, retrospectively discontinued the contribution cost and test cricket fund, and replaced it with a new model of distribution of surplus (i.e. dividends/distributions) to the Members. As a result, management had reversed the liabilities towards the contribution cost and test cricket fund to the consolidated statement of comprehensive income during the year 2017 and classified the amounts paid to Members as per the new financial model as advances to Members.

In 2023, these advances have been offset against the surplus distributed to Members with the first tranche of such distribution (i.e., dividends) amounting to USD 300 million declared during the year 2020 and the second/final tranche amounting to USD 1,418.5 million declared during the year 2023, both with the approval of the Board of Directors.

#### FINANCIAL MODEL: 2024–2027 CYCLE

In July 2023, the Members approved a financial model for the period 2024–2027 aligning it with the ICC's largest revenue stream, the Indian media rights agreement. The principles of the new financial model are largely in line with the previous model with the incorporation of a Strategic Investment Fund and Contingency Allocation.

#### 2 BASIS OF PREPARATION

#### SUMMARY CONSOLIDATED FINANCIAL STATEMENTS

The summary consolidated financial statements have been derived from the audited annual consolidated financial statements of the ICC Group which were approved by the Board on 24 April 2025. These summary consolidated financial statements were authorised for issue on 24 April 2025.

The audited consolidated financial statements are available at the Headquarters of the ICC in Dubai Sports City. The summary consolidated financial statements are presented in considerably less detail than the annual audited consolidated financial statements for the convenience of readers and are consistent, in all material respects, with the audited consolidated financial statements.

The summary consolidated financial statements have been presented in US Dollars, which is the functional currency of the Company. All values are rounded to the nearest thousand (USD'000) except otherwise stated.

#### 3 NET DIVIDEND PAYABLE

#### Dividend payable

During 2023, the Group had adjusted an amount of USD 116.5 million in respect of the withholding tax on Media Rights payments for the ICC Cricket World Cup 2023 against the share of dividend payable to a Member. During 2024, the Group has received a refund of USD 61.5 million in relation to the above withholding tax which has been passed on to the Member. The Member has not disputed this adjustment of withholding tax on media rights payments for the ICC Cricket World Cup 2023 against the share of dividend payable.

#### 4 MEMBER DISPUTES

During the year 2019, the Group had adjusted the amount of USD 23.75 million due from a Member in respect of the withholding tax on Media Rights agreement for the ICC World Twenty20 2016 against their share of distributions as per the directive of the Board of Directors. The decision was based on the Board of Directors' assessment of the enforceability of the terms of the Host agreement dated 12 October 2014 between the Group and the Member.

In February 2020, the Member notified the Group via an independent legal counsel that the Member does not accept the offset of the withholding tax of USD 23.75 million and their liability for such taxes (together "the disputes"). The disputes were referred to the ICC Dispute Resolution Committee in April 2020, and proceedings thereof are yet to commence as of the date of authorisation of these consolidated financial statements.

#### 5 LOAN IN RELATION TO MEN'S T20 EVENT (STRATEGIC INVESTMENT COST)

As of 31 December 2024, the loan in relation to Men's T20 event held in USA represents Board approved interest bearing loan of USD 22,000 thousand (2023: USD 9,000 thousand). The Group has provided for the amount considered doubtful of USD 20,000 thousand (2023: USD Nil).

#### **6 UAE CORPORATE INCOME TAX**

On December 9, 2022, the UAE Ministry of Finance released the Federal Decree-Law No. 47 of 2022 on the Taxation of Corporations and Businesses to enact a Federal corporate tax regime ('CT Law') in the UAE. The CT law is effective for accounting periods beginning on or after June 1, 2023.

The Cabinet of Ministers Decision No. 116/2022 effective from January 2023, has confirmed the threshold of income over which the 9% tax rate would apply, and the CT Law is considered to be substantively enacted. A rate of 9% will apply to taxable income exceeding AED 375.000. A rate of 0% will apply to taxable income not exceeding AED 375,000.

One of the exempt persons specified under Article 4 of the CT Law is a Qualifying Public Benefit Entity ("QPBE"). The CT Law defines a 'Qualifying Public Benefit Entity' as an entity that meets the conditions set out in Article 9 of the CT Law and that is listed in a decision issued by the Cabinet at the suggestion of the Ministry. The Group management has applied for an exemption from CT Law for IBC and FZ LLC since based on management's assessment, even though IBC and FZ LLC have not yet been included as part of list of exempted entities in a decision issued by the authorities, the management believes that these entities meet all the other conditions set out in Article 9 of the CT Law. Considering all the substantive conditions required to meet the exemption criteria have been met for the year ended 31 December 2024, no provision has been recognized towards CT Law in these consolidated financial statements. The Group management has further represented the matter to the relevant UAE authorities to request that IBC and FZ LLC are granted exemption from the CT Law for the year ended 31 December 2024.
